Local News - October 15, 2020: Census ends; Taxes due.

Today is the last opportunity to participate in the 2020 Census. So anyone who has not yet participated needs to go directly to <a href="www.2020census.gov">www.2020census.gov</a> right now and do so right now and click the respond button.

I'm waiting.

The most compelling—and selfish— reason to participate is that allocations of Federal funds ties directly to the number of people counted in a particular region. Your collective responses determines the disposition of approximately \$1.5 trillion in federal spending is directed and how House of Representative and states are reapportioned and redistricted.

Jefferson County's self response rate is 66.3 percent, with 54.6 of that being internet response. Our Area Census Office in Olympia reports a 99.9 percent non-response follow-up. Field work included counting the homeless and group housing units and following up with those households that did not reply to the invitation sent earlier this year. Jefferson hosted several Census Pop-Ups at venues around the county to assist those who had not responded.

Originally the Census was set to end September 30, with population data delivered to the president at the end of December. In April, the Census Bureau requested that Congress grant a 120-day extension— for data collection to October 31 and population count delivery in 2021 because of the impact of the pandemic.

After legal challenges, District Court rulings and appeals, the Supreme Court Tuesday ruled that the count will end today.

Those who don't have access to a computer can call 844-330-2020 to complete the questionnaire.

The second installment of Jefferson County property taxes are due Monday, November 2, with no allowable payment extensions.

Those who have already paid their full property tax amounts or have taxes deducted from mortgage payments can ignore this deadline.

There are four drop boxes around the county for payment by check. They are located in the rear of the courthouse, Port Ludlow Community Bank and at 1<sup>st</sup> Security Bank in Port Townsend and Port Hadlock.

Taxes paid by mail must be postmarked no later than November 2. Credit card payments may be made online or by phone, but will be assessed a 2.5 percent fee. Better to pay with a Visa debit card, which costs a \$3.95 flat fee.

To request paperless tax statement delivery for 2021 via email instead of hard copies by USPS, sign up by clicking on the link "eNoticesOnline" on the Treasurer's Office webpage.

A warning against Paralytic Shellfish Poisoning (PSP), prohibiting shellfish harvesting is still in effect in 14 local waterways. Public access points are posted with warning signs.

As soon as toxins decline, the shellfish safety map will be updated by Washington State Department of Health and signs will be removed from public beaches.

\*\*\*

And the numbers: Jefferson County now has 80 reported cases of COVID-19. This even number is equally divided between men and women. 61 people are awaiting test results and the positive rate is .85 percent, well below the national average.

It is now 19 days until the General Election. Jefferson County mailed ballots to nearly 30,000 voters yesterday. They should begin to arrive in mailboxes today. Those who have If you do not receive your ballot by October 20th, next Tuesday, should call (360)385-9119 to correct the situation.
