Good afternoon. You are listening to 91.9 FM KPTZ in Port Townsend, Washington. I'm Simon Jaynes, joined in studio today by both my kids, with local news for January 27, 2022.

Jefferson County Public Health reported 33 new cases of COVID-19 yesterday. This brings our total case count, since the beginning of the pandemic, up to 2,453. There are currently 222 active cases in isolation and three Jefferson County residents are hospitalized. According to County Health Officer Dr. Allison Berry, we are seeing COVID-19 case numbers peak and plateau here in Jefferson County, much as they are doing across Western Washington. But in her words, "The key thing is to think of it as a mountain... we have reached the peak but we still have to come down the other side before we will see low rates of COVID."

Here at KPTZ we want to make sure our listeners are equipped with up-to-date health information to keep themselves protected. In the transcript to this broadcast, which is available at kptz.org you can find a link to the most current testing flowchart from Jefferson County Public Health

According to the School District website there have been 61 confirmed cases district wide in the last 2 weeks.

And what stands out to you right now? Either of you...

- Probably the coronavirus.

Ivan, what do you think is going well?

- That we're all here as a family.

What do you think, Syd? How do you feel about wearing masks and being tested for Covid and all that stuff?

– I'd rather not…but I'm fine with it.

What about you, Ivan?

– I want every kid to be able to do whatever he wants.

Well, I know off the top of my head that both of your schools are running pretty smoothly considering all the challenges that they are facing. I think on behalf of you kids here in the studio and all your friends and their parents we can give a big thank-you to the teachers and school staff, the medical staff, the parent volunteers, the health department the hospital, and just everyone keeping this thing going for the families in the community. Right fellas?

On Tuesday, U.S. Representative Derek Kilmer (of Washington's 6th district) announced that a pilot version of the bipartisan RECOMPETE Act was included in the America Competes Act of 2022. The Recompete Pilot Program will provide distressed local labor markets, local communities, and Tribal governments with flexible 10-year Recompete Grants to invest in a variety of local economic development needs and increase employment

rates. Grants could be used for infrastructure investments, workforce development, small business assistance, and other investments to help communities rebuild. Distressed communities, as identified by the Upjohn Institute for Employment Research, are home to almost one-sixth of the U.S. population where workers ages 25 to 54 experience significantly higher unemployment rates than the national average.

According to Rep. Kilmer. "That is why I'm proud that a pilot version of the RECOMPETE Act has been included in the America Competes Act of 2022. The Act is a bold proposal to provide flexible, long-term grant assistance to create jobs and lay the foundation for long-term economic growth." The companion legislation introduced by Senator Coons is co-sponsored by U.S. Senators Michael Bennet, Amy Klobuchar, and Jacky Rosen. Said Senator Coons, "I'm proud to partner with Representative Kilmer on this ambitious legislation that will target the most distressed communities with job opportunities, business investment, and resources for long-term economic growth."

The *Peninsula Daily News* reported yesterday that Jefferson and Clallam Counties have won grants to fund expansion of their respective broadband systems in the coming 2-3 years. Clallam County will receive \$20 million dollars from the state broadband office and Jefferson County is set to receive \$9.7 million. In Jefferson County, the grant will target areas that can't get a download speed of 25 megabytes per second or upload speeds of 3 megabytes per second. According to the *Daily News*, these areas include greater Cape George, but not actually Cape George Colony, from Middle Point to Discovery Bay. Other areas that will benefit from this grant are the Woodland Hills neighborhood and Marrowstone Island. The broadband grant will help provide more than 650 homes with high-speed internet access, O'Donnell said.
