Property owners can expect to see property tax statements in their mailbox this week, according to Jefferson County Treasurer Stacie Prada. Those who are enrolled in eNotices received the email on February 7 from help@enoticesonline.com with the subject line "Your new/revised eNotice is available from the Jefferson County Treasurer." Check your junk folder if you did not receive it.

Remember the deadline to pay first installment property taxes is extended to May 1, 2023 instead of April 30, because the due date falls on a weekend. According to Jefferson County Assessor Jeff Chapman, the total taxable value for the County rose by 21.32% in 2022 from 2021. Due to budget limitations for taxing district increases, collections went up by only 3.25%, less than inflation. The result was that while property values went up, levy rates for non-voted levies dropped, and taxes for the average homeowner only changed by a few percent. Property taxes may be paid by mail, online, at the drop box behind the Courthouse, in the Treasurer's Office in the Courthouse, or by AutoPay. The City of Port Townsend Planning Commission will meet with the Port Townsend City Council this coming Monday, February 13 at 6:30pm in City Hall Council Chambers. The purpose of this meeting is to meet jointly with the Port Townsend City Council at a Workshop Meeting to have Roll Call/Call to Order, receive General Public Comment, and discuss "Tactical Infill Housing." Councilmembers and Commissioners will discuss developing greater housing availability and affordability through "infill development" which includes attached townhouses, duplexes, quadplexes, accessory dwelling units (ADUs such as converted garages and "in-law apartments"), cottages, and mini-homes. The meeting will include city staff presentation, public comment, and council discussion. You can attend in these ways:

And, next Tuesday, February 14 is not just Valentine's Day, it's also a special election day in Jefferson County. There are two Levy Lid Lifts for East Jefferson Fire Rescue (EJFR) District 1. One will raise the EMS levy to the highest amount allowed under state law: \$.50 per thousand dollars of valuation, and the other, the FIRE levy, will increase the amount but will be shy of the maximum under state law to \$1.30 per thousand dollars of valuation. EJFR Fire Chief Bret Black was quoted in the *PT Leader* recently and said, "Our revenue cannot grow without a community-approved measure – without the vote of the community – more than 1%, so over the past 10 or 11, 12 years, we have not kept up with inflation." After cutting more than \$3 million from the 2023 budget, the department still fell short by more than \$2 million. This shortfall will reduce its budget reserves to

34% by the end of the year, and if continued unabated through 2024, will leave reserves below the 25% level that department policy mandates.

The Brinnon Fire Department, Jefferson County Fire Protection District 4, is bringing its own set of tax propositions to the ballot for the upcoming special election. The measures separately ask voters to authorize a property tax levy lid lift to \$1.50 per \$1,000 of assessed property value for general maintenance and operations of the fire department, as well as \$.50 per \$1,000 for Emergency Medical Services (EMS).
