On Tuesday Dr.Allison Berry gave a Public Health Report to the Jefferson Board of County Commissioners (BOCC) She stressed that the national COVID-19 numbers have fallen and have plateaued, and that could mean a continued downward trend or they could be about to rise again.

She said that Jefferson County has very good uptake of the bivalent boosters – roughly 50% – and that is good. However, the most severe cases of the disease are among the elderly and among those with co-morbidities who have not received the booster shots. She strongly recommends those most vulnerable among us get the bivalent shot. She also said that a listener reminded her that there are many KPTZ listeners in East Clallam County, and requested the COVID-19numbers from there in her report.

So, those numbers, as reported by Dr. Berry are: 100 cases per hundred thousand, with the case ascertainment rate there being 1 in 20, far lower than Jefferson County because home COVID-19 tests are not being counted there. There are 3 people currently hospitalized and a total of 161 deaths in Clallam County due to COVID-19. The most recent death was last week, a woman in her 90s who died as a result of one of the long-term care outbreaks, who had underlying conditions and both influenza and COVID-19 at the same time.

Covid Numbers were also updated Tuesday morning for Jefferson County: Jefferson County Public Health reports that 61 new cases were added in the past week, so there have been 6,917 cases of COVID-19 since the pandemic began. The previous case rate was 237 per hundred thousand and it is still high at 243 per hundred thousand. The County estimates only 1 in 14 cases are currently being reported, so it is high, and extremely high if we multiply: Over 2,430 cases per hundred thousand and about 610 new cases in the past week. There are 2 patients currently hospitalized, and no new deaths have been reported, leaving the total number of those who have died at 34 due to COVID-19 in Jefferson County.

It is still strongly recommended that we all wear a high quality, well-fitting mask in public indoor settings. As reported in the *PT Leader* Monday and here on KPTZ Tuesday, a 50-year-old Port Townsend man was arrested for first-degree assault as police continued to investigate the stabbing of a 42-year-old woman in a motorhome, an RV, on Sunday morning. The story was updated yesterday. The alleged assailant, John Lewis Allen, was ordered held on \$500,000 bail. Allen made his first appearance in Jefferson County Superior Court Tuesday. Deputy Prosecuting Attorney Tuppence Macintyre asked that bail be set at half a million dollars, given the violent nature of the alleged assault, and is quoted in the *PT Leader*, "This is a very serious, violent offense." She noted that the same victim had a no-contact order against Allen, one that stemmed from a March 2022 second-degree assault case where Allen was arrested after he allegedly strangled the victim. Allen was also arrested on a third-degree assault against the same woman in December 2022 while a separate no-contact order was in place.

Macintyre praised the "Good Samaritan neighbors who called law enforcement and saved her life" as well as the quick thinking of responding officers. Macintyre said of the woman, "She has very serious injuries." Detective Anglin with the Jefferson County Sheriff's Office, said multiple neighbors called 911 about 11:30am and said Allen was taken into custody and gave a long, "convoluted" history of his relationship with the woman.

A deputy wrote in the statement of probable cause for Allen's arrest: Detective Anglin said "In the process, he believed she was involved in planting a device inside of him..." Allen also allegedly said the woman had implanted devices into the bodies of other people, all of whom had injuries to their right legs that was evidence of the implants. He also talked about his neighbors having large amounts of WiFi signals, and mentioned tracking devices that followed law enforcement officers. According to court documents, "Allen made several other odd statements related to secret websites, video tampering of his security cameras, and many other strange statements. Allen's next court appearance has been scheduled for Friday, February 24.
