# **Introduction to KPTZ Underwriting**

KPTZ is a non-commercially FCC licensed radio station, so cannot broadcast any advertising. Instead, and even better, KPTZ underwriters and event sponsors receive on-air acknowledgments in exchange for financial contributions.

- Expand and build brand awareness by targeting an engaged, local audience.
- **Generate goodwill** in the community by linking your business with a civic, cultural and educational media outlet.
- **Enhance your image** and relationships with KPTZ members and volunteers by supporting an essential community resource.
- Our listening audience reaches far beyond the Olympic Peninsula and internationally, streaming live at kptz.org.



# The KPTZ Audience — Demographics and Values

Based on our current donors and volunteers, we know our supporters are creative and bright achievers and opinion leaders. They are community-minded, supporting media, arts and culture. In addition, our signal reaches the many tourists visiting the local area. **Thanks to our 24/7 online streaming, we have members across the country and around the globe, extending KPTZ's voice beyond the region.** 

KPTZ is a community radio station (and not an NPR affiliate, public radio station). Our listening audience composition reflects our members, donors and volunteers who come from different ages and backgrounds, different religions and political persuasions. **The KPTZ listenership is eclectic and diverse, representing a cross section of life in our community.** 

On KPTZ you will not have to vie for the attention of a listener already bombarded by an endless stream of advertisements. **Your message will be heard, in an uncluttered audio environment.** 

# **Underwriting Rates and Information**

#### **Standard Rates**

**KPTZ's standard underwriting rate is \$15/spot.** A minimum of 30 spots is required for the initial flight of a single announcement, and these are scheduled as "run-of-station." There is presently an introductory offer for 20 spots of shorter length, please inquire if interested.

## **KPTZ Underwriting Copy Guidelines**

KPTZ's underwriting staff will help you construct your message. By adhering to FCC guidelines for best practices, your announcement will be legal and more importantly, it will be heard and well received by our station listeners.

- Maximum length is 25 seconds.
- Underwriting spots are pre-recorded by KPTZ volunteers.
- KPTZ maintains the responsibility to edit underwriting copy for compliance with FCC regulations and station policy.

We simplify everything by managing the process, from the contract through recording and production, then schedule for broadcast on air. Normally there is a maximum of two underwriting spots per hour. These are nominally priced, and since you are receiving the benefit of your contribution's value in on-air announcements, this is a true marketing benefit. And, underwriting is a business expense — so you are making a contribution with true promotional benefits. Also, our community business supporters are all displayed as links on the KPTZ.org's Underwriting page.

#### **In-Kind Announcements**

Any trade of goods or services for on-air underwriting is subject to the station manager's advance approval. KPTZ's \$25/spot base rate for in-kind underwriting takes into consideration station overhead in scheduling, producing and broadcasting these announcements.

# What underwriting content is acceptable to the FCC?

Stations are allowed to identify, not advertise, commercial entities that provide general support for the station. This identification can include the following:

- Name of the business or entity,
- Location information,
- · Website addresses,
- Value-neutral descriptions of a product or services,
- Brand names and trademarked slogans,
- Product or service descriptors that do not include qualitative language.

### What underwriting content is *not* acceptable to the FCC?

According to the FCC, the purpose of an underwriting message is to identify, rather than promote, noncommercial radio supporters. Each licensed broadcaster is expected to make reasonable, good faith judgments about language used in underwriting copy to ensure that the station adheres to this basic principle. Non-compliance can bring about stiff penalties.

- Price related information including discounts,
- Interest rates or references such as free, on sale or specials,
- Comparative or qualitative descriptions such as best, most reliable, largest selection, nationally acclaimed,
- Calls to action using the imperative demand, such as: learn more, come by, or try product.

### **Examples of a 25-second Sustaining Underwriting Spot**

**KPTZ** accepts cash, checks, debit and credit card payments. Full or first payment is due at signing of the contract.

- Services rendered by KPTZ are subject to suspension whenever the client payment is not received ahead of airtime.
- Agreement terms will be executed upon contract signing unless otherwise arranged. It very rarely happens, yet scheduling and underwriting rates are subject to change. KPTZ will notify the client as soon as possible for any such change.
